- Having seen the Sub-Decree No. 174/ANK/BK, dated 31 August 2022, on Promulgating the Standard Operating Procedures For Public-Private Partnerships Projects;
- Having seen the Sub-Decree No. 234/ANK/BK, dated 18 October 2024, on Promulgating the Management of the Viability Gap Financing Facility for Public-Private Partnerships Projects;
- Pursuant to the Request of the Minister of Economy and Finance;

HEREBY DECIDES

Article 1._

Has identified the priority sectors for the implementation of public-private partnerships project for 10 years duration (2025 - 2035) as follows:

- 1- Transport and logistics sectors (Roads and bridges, ports and logistics)
- 2- Energy sector
- 3- Public services sector (Clean water supply and waste management).

In the case that there are further decisions from The Government of the Kingdom of Cambodia, projects in other sectors may also qualify for inclusion in the public-private partnerships priority projects list in accordance with applicable procedures.

Article 2._

All existing provisions contrary to this decision are hereby abrogated.

Article 3._

The Minister of Council of Ministers, the Minister of Economy and Finance, Ministers of all ministries, Heads of all relevant institutions, and subnational administration shall implement this decision within their respective functions from the date of signing.
