- Pursuant to the necessity of the Ministry of Economy and Finance

HEREBY DECIDES

Article 1._

The purpose of this Prakas is to implement a mechanism of collecting Administrative Fees from private partners to support administrative activities associated with the implementation of Public-Private Partnerships (PPP) projects and to ensure the sustainability of the Project Development Facility for PPPs (PDF for PPPs), in accordance with Article 12 of the Law on PPP and other applicable regulations.

Article 2 ._

The scope of this Prakas shall cover all PPP projects, excluding those that have completed the procurement phase or signed the Framework Agreement and executed a PPP Contracts.

Article 3._

The rate of Administrative Fees obtained from private partners shall be determined as follows:

A. Solicited Proposal: 2% (two percent) of the actual project preparation cost funded by the PDF for PPPs.

B. Unsolicited Proposal: 2% (two percent) of the actual project preparation cost if funded by an advance payment from the private partner or 5% (five percent) of the actual project preparation cost if funded by the PDF for PPPs.

The rate of Administrative Fees shall be subject to change with the approval of the Minister of Economy and Finance.

Article 4._

The Administrative Fees collected from private partners, as stipulated in Article 3 above, shall be deposited into the PDF for PPPs account and must be explicitly stated in the bidding documents for Solicited Proposals or in the Framework Agreement for Unsolicited Proposals.

Article 5._

All existing provisions contrary to this Prakas are hereby repealed.

Article 6._

The Head of the Cabinet of the Deputy Prime Minister, the Secretary-General, the Royal Government Delegates in charge as the Directors General of the General Departments, the Director General of the General Department of Public-Partnerships, the Director Generals of all General Departments, the Inspector-General of the General Inspectorate, and Heads of all relevant Units under the Ministry of Economy and Finance shall implement this Prakas from the date of signature herein.
